Application for Herd Registration

Please note that it is <u>not compulsory</u> to enrol a Herd Prefix and Herd Code when joining the Association. However, herd enrolment will be necessary to enable registration of any animals that you breed in New Zealand.

Herd Prefix

Your Herd Prefix is used as a prefix to, and as part of the name of the alpaca you register (e.g., Green Park Jason). Many breeders use their property name as their Herd Prefix. However, the Herd Prefix of any herd must be unique within the Alpaca Association NZ Inc. Choice of Herd Prefix (submit two, each of 16 letter max – includes spaces if more than one word.)

Herd Code

Up to three (3) alpha or numeric characters used to identify your herd. The Herd Code is the first part of the Ident Number of animals born in your herd (e.g., GPA may be assigned as the Herd Code and the first alpaca born in 2007 would be GPA C0001).
