He believes that the education of breeders is paramount at shows by conveying descriptive and meaningful critiques while providing reliable comparisons for breeders to assess. This then allows breeders to be able to visualize what has been said by the judge.

Prior to becoming a judge, Dean had previously undertaken various volunteer leadership roles for the AAA in Australia, including President of Victorian Central Region (VCR) and convenor of Colourbration in Bendigo, Australia which then was Australia's largest alpaca color show.

Dean has a passion for fiber and wool classing, he successfully completed his professional Wool Classer certificate with AWEX in 2012 becoming a registered classer.

He also assisted pilot the alpaca fiber classing programme within the TAFE system in Australia completing the competency.

In 2022 Dean was honored to be asked to judge the fleece at the World Alpaca Conference in Graz, Austria. It was an amazing opportunity to be involved in the growth of Alpaca in Europe.

Lisa loves getting the opportunity to judge at shows as it allows breeders to hear descriptions and comparisons between the animals in each class which ultimately can help and enhance their future breeding.

She hopes that every breeder, whether they walk away from a show she has judged with a ribbon or not, takes away some helpful knowledge from the day.

As well as being a qualified New Zealand Alpaca Judge, she was also part of the Australian Apprentice Judges programme, co-convened the 2019 NZ National Alpaca Show, was on the AANZ Showing & Judging committee, and her and Dean also spent 3 weeks in Europe in 2023 judging the fleece section at the World Alpaca Expo in Austria.

Conditions of Entry

- 1. All Alpacas to be penned by 8.00am Saturday 2nd **November 2024**. Judging to commence at 9.00am. This show is run under the Rules and Regulations of AANZ.
- 2. All animals must belong to a clear TB herd where whole herd testing is performed in accordance with the AANZ voluntary TB scheme and either (a) the herd they came from has a current valid (clear) TB whole herd certificate and is situated outside any Declared Movement Control Area for cattle and Deer as defined and mapped by the Animal Health Board or (b) the herd they come from has a current valid (clear) TB whole herd certificate and they are situated within any Declared Movement Control Area for Cattle and Deer as defined and mapped by the Animal health Board and the specified alpacas attending the Show have been tested clear of TB within 60 days of the Show.

All alpacas entered in Championship Classes and Non-Championship Classes must be registered with the IAR and carry a brass ear tag displaying its Corresponding IAR number. Copies of registration certificates do not need to be submitted, just the IAR written clearly on the entry form.

- 3. All alpacas must be registered by the Show date.
- 4. The exhibitor is the owner(s) listed on the IAR.
- 5. The age of the alpaca is the age on the day of the show.
- 6. All exhibitors or handlers must place their animals in the pens allotted by the convenor. Placement of animals in "trade/Sales pens" can be done with the permission of the Convenor.
- 7. No animal shall be removed from the show prior to the completion of judging.
- 8. All exhibitors must be a financial AANZ member.
- 9. If the timetable is revised all exhibitors will be advised prior to the Show.
- 10. Entry fees are non-refundable where entries are subsequently withdrawn from competition or exhibitors fail to attend the show.
- 11. Animals are to be entered in the correct class for the colour of the animal, not necessary the colour shown on the IAR certificate. Colour checks can be requested at the time of registration on show day. See the Chief Steward if you have any doubts about the specific colour class of your animals.

The **Dress Code** for our show is black trousers/skirt and white shirt/blouse and preferably black shoes. Having all exhibitors dressed neatly in a similar attire makes for a professional image to the public.
