Individual/Partner/Corporate Membership

- Receive all correspondence, information and updates
- Receive regular newsletters
- Register a stud name, as alpacas have a pedigree registry
- Register eligible alpaca on the IAR(NZ) once a stud name has been registered
- Have a right to vote at AGM and SGM
- Individual and partner members can hold any office in the association
- You can exhibit at shows
- Corporate members can appoint up to 2 nominees to exercise the rights of membership on its behalf but cannot hold any office in the Association

Lifestyle Membership

- Receive all correspondence, information, and updates
- Receive regular newsletters
- Can register a stud name, on the IAR(NZ) Alpaca Registry
- Can register eligible alpaca on the IAR(NZ) once a stud name has been registered
- You can exhibit at shows
- Ineligible to vote or stand for election to any office
- No ability to register cria, progeny or certify sires

Subscription fees are for the period of 1st April through to 31st March of each year and are listed below.

If you join, as a first-time member after 1st October a reduced fee is charged for the shorter period. Thereafter annual membership rates will apply and are invoiced on the 1st of April each year and are due by the 20th May that same year.

When your application has been accepted, you will receive a tax invoice/receipt attesting that you have paid the fee.
